

The intending Tenderers are requested to submit their tenders in plain paper offering their bids duly sealed along with one Bank Draft worth Rs 1000 (Rupees One thousand) Only drawn in any Nationalised Bank as E.M.D in favour of District Manager, OSCSC Ltd, Bhadrak. The tenderers are required to send the tender papers strictly through Registered Post/Speed Post/ Courier Services. The last date of receipt of tender is Dt.28-08-2018 at 3 P.M. The tender papers received after the specified date and time as mentioned above shall not be entertained and the same shall be out rightly rejected. The sealed tenders shall be opened on Dt-28-09-2018, at 4 P.M in the office chamber of Additional District Magistrate, Bhadrak in presence of tenderers or their authorised representatives. The tenderer may inspect the vehicle kept in the premises of Sri Hanuman Rice Mill at Chandabali during any working day from 10.30 AM to 05.00 PM. The Up-set price of vehicle No- OR-02F-8946 has been fixed to Rs.70,000.00

#### Terms and Conditions:

1. Quotation should be sent by mentioning "Auction Sale of the Vehicle No- OR-02F-8946 on the top of the closed envelope containing the E.M.D.
2. The tenderer with highest bidding shall be selected by the competent authority. He shall deposit 25% of the bid amount immediately on the spot and rest amount shall be deposited within seven days.
3. The E.M.D of all unsuccessful tenderers will be refunded to them on the same day.
4. If the price offered by sealed tenders are found less than the upset price, then competent authorities may go for fresh auction sale or negotiation may be made with all the present tenderers to fetch the minimum up-set price as desired by the authority.
5. In case the successful tenders fails to deposit 75% of balance auction price within 7 days, his tender paper will be cancelled and the E.M.D along with 25% deposit will be forfeited.
6. The highest bidder will remove the vehicle within 15 days of deposit of the total amount failing which ground rent of Rs 100/- per day will be charged till final removal of vehicle.
7. After obtaining ownership by the highest bidder in his name from the RTO the vehicle will be handed over to him subject to production of documents in this respect.
8. Where the ground rent so charged exceed the price deposited by the tenderer, shall ceased to have any right on the vehicle and amount so deposited by him will be adjusted towards ground rent. The vehicle shall become absolute property of the Corporation free from all encumbrances and it will be disposed of by fresh auction/tender as the case may be.
