Cuttack in presence of the tenderers or their authorized representatives, if they wish. The tenderers may inspect the vehicle kept in the premises of RRC, Sadar, Nayabazar, Cuttack during the working day between 10.30 A.M. to 5.00 P.M.

**TERMS AND CONDITIONS :**

1. Tenderers should be submitted by superscribing "Auction sale of the Vehicle No. OR-02-L-5881" on the top of the closed envelope containing the EMD.
2. The Tenderers with highest bidding shall be selected by the competent authority. He shall deposit 25% of the bid amount immediately on the spot and the rest amount shall be deposited within 7 (Seven) days or at the time of taking delivery of the vehicle, whichever is earlier.
3. The EMD of all unsuccessful tenderers will be refunded to them on the same day.
4. In case of successful tenderer fails to deposit 75% of balance auction price at the time of taking delivery of vehicle within 7 days, his/her deliver order will be cancelled and the EMD along with 25% deposit will be forfeited.
5. The highest bidder will remove the vehicle within 15 days of deposit of the total amount failing which ground rent of Rs.100 /- per day will be charged till final removal of the vehicle.

6. After change of ownership by the highest bidder in his/her favour, or cancellation of registration of the vehicle at RTO, Cuttack, the vehicle will be handed over to the highest bidder subject to production of documents in this respect. An agreement will be made with the highest bidder in stamp paper towards disposal of said vehicle and hence forth this office will not be responsible for any type of pending dues / penalties and claim etc.. as the case may be.
7. Where the ground rent so charged exceed the price deposited by the tenderers, shall ceased to have any right on the vehicle and amount deposited by him will be adjusted towards ground rent. The vehicle shall become absolute property of the Corporation free from all encumbrances and it will disposed of by fresh auction / tender as the case may be.


