All are invited for auction sale of one Maruti 800 Car No.OR-02C 4257 of Odisha State Civil Supplies Corporation Ltd., plot No. C/2, Nayapalli, Bhubaneswar-12, on "as is where is basis along with all available documents". The intending parties are requested to attend the office for negotiation on dt 04.08.2021 at 4.00 PM in the office chamber of FA & CAO at Head Office in order to fetch the minimum upset price of the said vehicle along with one Bank Draft, worth Rs. 3,000.00 (Rupees Three thousand) only as E.M.D drawn in any Nationalized Bank in favour of Managing Director, OSCSC Ltd.,Bhubaneswar. The instrested parties may inspect the vehicle kept in the premises of Corporation Head office C/2,Nayapalli,Bhubaneswar during any working day from 10.30 A.M to 5 P.M.

Terms and Conditions:


1. All the parties will offer their price against vehicle in front of all participants.
2. Negotiation will be made along with the parties irrespective of their previous offer to meet the minimum upset price of this vehicle.
3. Accordingly to the bids, offered by the parties, top-three will be emplaned and out of which the highest bidder will be declared then and there.
4. The EMD of top-three participant will be kept reserve for 7 days & the EMD of all unsuccessful tenderers will be refunded to them on the same day.
5. The parties with highest bidding shall be selected by the competent authority. He shall deposit 50% of the bid amount immediately on the spot and rest amount shall be deposited within 3 (three) days or at the time of taking delivery of the vehicle, whichever is earlier.
6. In case the successful parties fails to deposit the required amount in time then the EMD along with all deposit of the same party will be forfeited and the 2nd highest bidder will be given a chance for the vehicle as per previous procedure of deposit of bidding amount.

If the 2nd highest bidder fails to deposit the required amount in time then his EMD & all other deposit will be forfeited and the 3rd bidder from the panel will be given a chance to dispose of the said vehicle after deposit of entire bidding amount by the 3rd bidder.

If all the bidders fails to take the vehicle with due deposit of the bidding amount, then the competent authority may take any decision to dispose of the said vehicle for better interest of the Corporation.


7. The highest bidder will remove the vehicle within 15 days of deposit of the total amount, failing which ground rent of Rs. 100/- per day will be charged till final removal of vehicle.
8. After change of ownership by the highest bidder in his/her favour, or cancellation of registration of the vehicle at RTO BBSR, the vehicle will be handed over to the highest bidder subject to production of documents in this respect/ An agreement may be made with the highest bidder in stamp paper towards disposal of said vehicle and hence forth this office will not be responsible for any type of pending dues/penalties & claim etc as the case may be.
9. Where the ground rent so charged exceed the price deposited by the tenderer, shall ceased to have any right on the vehicle and amount so deposited by him will be adjusted towards ground rent. The vehicle shall become absolute property of the Corporation free from all encumbrances and it will be disposed of by fresh auction/tender as the case may be.
10. The authority reserves the right to accept or reject any or all the tenders without assigning any reasons thereof.


