Sub: **Functioning of Departmental Storage Centres - Guideline for purchase of Quality Control Equipments.**

Sir,

Inviting a reference to the subject cited above, I am to say that Govt. in F.S. & C.W. Deptt. have decided for functioning of Departmental Storage Centre (DSC) and for door step delivery of stock from RRC-cum-DSC at retail points. To ensure receipt and issue of food grains on prescribed quality norm, it is required to make available equipments for quality testing of food grains at Rice Receiving Centres cum Departmental Storage Centres (RRC-cum-DSC).

The following equipments are required for quality testing of food grains in RRC-cum-DSC.

1. One moisture meter.
2. One sample divider.
3. One set of sieves.
4. One analysis kit with following accessories:-
 1. Mechanical weighing balance upto 100 gms. capacity with weight box -one.
 2. Enamel plate – 9¹¹ – one
 3. Parkhi - 9¹¹ – one
 4. Sieve 3.3 mesh – one
 5. Magnifying glass – 1.5 inch – one
 6. Vernier micrometer – one
 7. Palm paddy dehusker – one
 8. Scoop (one set) – one
 9. Measuring cylinder – 20ml – one
 10. Built in purity work board – one (attached)
 11. Petri dish (one set) - one
 12. Forcep – one

(All packed in a wooden brief case)

All above equipments shall be purchased at district level as per the rate approved by OSAMB / SLTC of A & FP Department from their approved firm.

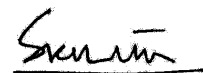

Realistic requirement shall be assessed and the District Manager accordingly place order directly to the approved firm with the approval of Collector.

- (1) The approved firm of quality testing equipment shall demonstrate functioning of each equipment before the godown staff at the time of delivery so that the staff can gather basic knowledge to operate with the equipment subsequently.
- (2) No equipment shall be provided for the godown of CWC & OSWC under use or hire godown under their management where the proposed Departmental Storage Centre will function.
- (3) District Manager, OSCSC Ltd. are allowed to purchase more than one set of above equipments if required considering volume of operation and storage capacity.
- (4) In the existing RRCs where any of the above equipments are available in good working condition, the requirement may be revised accordingly.
- (5) The approved firm of quality testing equipment shall demonstrate functioning of each equipment before the godown staff at the time of delivery so that the staff can gather basic knowledge to operate with the equipment subsequently.
- (6) All the equipments after purchase shall be entered in asset register maintained at District Office and RRC-cum-DSC.

I am to request you to asses the requirement of equipment at an early date and place the order with the suppliers well in advance. In no case RRC-cum-DSC shall be allowed to operate without required equipments.

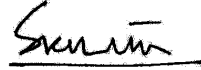

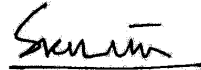
