Sub: Lifting of levy sugar against Govt. allotment for the month of Sept'10.

Sir,

Available stock of 127.6 M.T levy sugar in 100 kg Jute bags from Aska Co-Op. Sugar Industries Ltd & & 134.5 M.T levy sugar from Zonal Depot, Jagannathpur is hereby released in favour of Kandhamal district against Govt. allotment for the month of Sept'2010.

The stocks may be lifted from the Aska Co-Op. Sugar Industries Ltd, by the storage agents positively by 15.11.2010. The cost of sugar should be deposited with the Mill @ Rs. 1777.18 per qtl. (Inclusive of all taxes) from the available funds at your disposal. The allotted stock from Zonal Depot Jagannathpur should also be lifted by 15.11.10. The following guidelines may be scrupulously followed and action taken in the matter may be faxed to the undersigned early.

- i) As communicated vide this office letter No- 9926 dt-30.09.09 the allotted sugar stocks of a block, if completely lifted by 15.11.2010, the same may be distributed to the consumers during 2<sup>nd</sup> phase distribution of BPL rice for Nov'10. Adequate prior publicity in the area may be made.
- ii) A copy of the Block wise & Retailer wise distribution list may be communicated to the Hon'ble M.P., M.L.A. & Local Public Representatives of the area and Govt. in FS & CW Deptt. The B.D.Os / Sub-Collectors may be instructed to communicate the dealer wise allotment to the G.Ps and concerned retailers for information of General Public.
- iii) The stock should be lifted from the Sugar Mill & Zonal Depot on proper weighment and also delivered by the S.As to the retailers on proper weighment.
- iv) The scale of supply of sugar to the BPL and AAY families is @ 2 kg per card per month @ Rs.13.50 per kg. All efforts may be taken to make available levy sugar at the prescribed scale to genuine consumers and stringent action be taken against the offending retailers indulging in black marketing and charging higher rate.

- v) It may be ensured that the full cost is deposited by the concerned agencies in shape of Bank Draft drawn in favour of the Managing Director, OSCSC Ltd. The delivery orders in their favour may be issued only after deposit of such drafts by them.
- vi) In no circumstances the transportation charge should exceed the approved Govt. rate i.e. Rs.7.00 for the first 10 kms and @ Re.0.30 for the subsequent kilometer. Transportation to the destinations should be always through the shortest distance.
- vii) The CSO-Cum-District Manager and other officers should ensure proper distribution of the stock in the field.
