## **Specification of Antivirus (Cloud Based)**

- 1. Must offer comprehensive client/server security by protecting enterprise networks from viruses, Trojans, worms, hackers, network viruses, mixed threat attack from multiple entry points, and spyware. Anti-malware protection and cleanup capability with Centralized Quarantine and Restore of an infected file.
- 2. OEM Must have Own Antivirus Engine which is Certified by Industry Standard e.g. AV test, AV comparatives, VB100, ICSA labs, checkmark etc., additionally in AV Comparatives it should Achieve Performance Test with lowest impact score < 1.0 and Malware Protection Rate 99.7 or above.
- 3. The Real-World Protection rate should be equal or more than 99.6% in Latest AV comparatives (March to June) 2019 report in Enterprise Category.
- 4. Must have Real time virus protection including email scanning with Zero Hour Protection. Heuristic scanning & behavioral protection for web browsers, documents & programs. Capability to detect and block ransomware attacks.
- 5. Must have capability to scan and report vulnerabilities present in installed applications with summarized report of vulnerabilities as per severity level i.e. (High, Medium and Low).
- 6. Must have Filter option for search by Computer Name, Number, Group, Group Admin, Update Status, Protection Status, Operating System, IP Address.
- 7. Must have Smart firewall with functions to manage clients based on policies even when they are not in-home network.
- 8. Must Provide URL filtering, Application Control, Device Control in single console without the means of ADD ON.
- 9. Must have Intelligence to control Application exe's from running/executing, internet access, network access and should also include file hash (md5) blocking.
- 10. Must Provide Complete Information about Endpoint Hardware details with notification to administrator on the event of changes.
- 11.Must compare the traffic against a known set of Intrusion Detection signatures.
- 12. Must inspect applications, as well as the applications' sub-components (DLLs), as they are executed.
- 13. Must have Minimum system resource (RAM, CPU) utilization both in idle and full system scanning mode. Necessary proof to be submitted for the same.

- 14. Server setup File size should not more than 510 MB, with single client setup file for 32bit & 64bit both.
- 15. Must have the provision for auto update of console server, which eliminates the need for console server reinstallation upon any new version release.
- 16. Must have an option to implement immediate policy changes globally for the clients irrespective of any specific Group/Clients.
- 17. Must offer Inbound & Outbound port blocking, IP Address/subnet blocking, protocol blocking.
- 18. Must have Device control mechanism to block USB pen drives, ODD, floppy, Wi-Fi with intelligence to allow usage of USB keyboard, mouse, data card etc.
- 19. Must have Device access functions like completely block, allow read only, allow write, allow executable, also with password protection for access on client system.
- 20. Should have Device block by Device ID or GUID/Class ID or Wild Character.
- 21.Must provide Wi-Fi Protection for unrecognized SSID's with allow/block rules.
- 22.Must provide Device control mechanism with complete control on Data Access/Device Access with specific Device exclusion by the Device ID.
- 23. Must have the option to store Quarantine the files on central server / Console system.
- 24. Solution should have the provision to create custom Web Category which must get added in Pre-defined Web Filtering List.
- 25. Must have remote deployment feature with options like Workgroup Scan, IP Range, and AD Sync on Specific Endpoint.
- 26. Must have a feature to immunize USB Device to ensure device/data safety if it is used on an infected PC.
- 27. Must have tamper Protection on Endpoints which will prevent users from attempt to disable security measures or uninstall the anti-virus application.
- 28. Must be able to distribute new and update anti-virus software, virus definitions and configuration files automatically to clients and servers from a central location.
- 29. Must provide Simple and Comprehensive security reports with Email Notification of security events whenever Administrator attention is required (e.g. Virus outbreak on the network, Virus definition out-of-date, Security Patch required, etc.).
- 30. Must have Support for Business Server, File Servers, Desktops and Laptops. With Unlimited Client / Endpoint support.
- 31. Must have web-filtering, Application Control, Device Control to be present by default and not by means of ADD ON.
- 32. Must have the capability to add trusted device in network and also can add un-trusted devices in black list category.

- 33. Should be able to update definitions & scan engine on the fly, without a need for reboot or stopping of services on servers.
- 34. Should be able to add files, folders or extensions to an exclude list so that they are not scanned on access.
- 35. Should allow for incremental virus definition and scan engine updates. with offline updater tool in exe format.
- 36. Must have the capability to block access of some Google accounts and services while allowing access only to your managed Google accounts such as G Suite.
- 37. Must have a feature to immunize USB Device to ensure device/data safety if it is used on an infected PC.
- 38.License Management: Console should have option of easy release of license and reinstallation of same in other system.
- 39. The OEM must have done single deployment of 1000+ license in 2 or more govt. organizations in Odisha within last 3 years and should be operational on single console.
- 40. The OEM must have their support center, Operational office and Virus Labs in India.
- 41. Brands can quote: K7, ESET, Symantec & McAfee.
