TERMS AND CONDITIONS

- a) The tenderers shall quote the item wise price along with GST (Goods & Service Tax) chargeable separately in the quotation.
- b) A Copy of the valid GST No. & PAN should be furnished with the quotation.
- c) The tender paper without required amount of EMD and documents as mentioned will not be accepted.
- d) The Tender paper without required specification as mentioned will not be accepted.
- e) The Specification quoted in the tender paper against a specific model of any OEM should match the specification mentioned in the website of the OEM. The customized or assembled product will not be accepted.
- f) The quoted price shall be valid for 1(one) year from the date of Purchase Order/Supply of items, whichever is later & which may be extended for subsequent years on mutually agreeable conditions by both the parties.
- g) The Purchaser reserves the right to vary the quantity i.e. increase or decrease the number of materials without any change in terms and conditions at the time of placing the orders or during the execution of the Contract.
- h) The tenderers shall supply the required items as and when necessary within the stipulated time frame by the Corporation.
- i) Supply of Online UPS shall be made only as per the accepted rate and as per the order given by the Corporation from time to time.
- j) The UPS must be compatible with Li-ION Battery.
- k) The supply of intended articles shall be made available within 7 (seven) days from the date of issue of indented order.
- I) Failure to supply and installation of the total quantity of Online UPS within the stipulated time the supply order shall be cancelled along with forfeiture of EMD.
- m) The EMD amount of the successful tenderer will be kept as security for 1 Year in service support purpose.
- n) The EMD of all unsuccessful tenderers will be refunded to them on the same day with proper acknowledgment.
- o) The selected vendor may agree to deliver the items as per our requirement at the District level throughout the state at his own cost. No extra charges will be paid beyond the quoted price duly approved by the committee.
- p) The Selected vendor must provide service support for the Online UPS with no extra charge within the warranty period.

- q) In the event, any of the materials / equipment supplied by the Contractor is found defective due to faulty design, bad workmanship, bad materials used or otherwise not in conformity with the requirements of the Specification, the Purchaser shall either reject the materials / equipment or ask the Contractor in writing to rectify the same. The Contractor on receipt of such notification shall either rectify or replace the defective materials/equipment free of cost to the Purchaser.
- r) Bidder should have registered Office in the state of Odisha i.e. location of consignee registered since last 1 year from the date of publication of Tender.
- s) The OEM must have an existing Service center in Odisha. (Address proof required for physical verification).
- t) If required Proof of Concept Test of the product will be done in the premises of purchaser before finalization of the Award of Contract to the successful bidder.
- u) Within 15 days of the receipt of Notification of Award / Letter of Intent from the Purchaser, the successful Bidder shall furnish the Performance Security in the form of Bank Guarantee for an amount of Rs.100000/- (Rupees One Lakh only) executed on non-judicial stamp paper worth of Rs.100/- (Rupees One hundred only) issued by a Public Sector Bank in favour of Managing Director, OSCSC Ltd.
- v) Timely Servicing/rectification of defects during warranty period: After having been notified of the defects/ service requirement during warranty period, seller has to complete the required service/rectification within 10 working days time limit. If the seller fails to complete service /rectification with defined time limit, a penalty of 0.5% of Unit price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer. The Buyer shall have right to recover all such penalty amount from the Performance Security (PBG).
- w) In the event of any dispute arising out of this contract the jurisdiction of court shall be at Bhubaneswar for both the parties.
- x) The authority reserves the right to accept or reject any or all tender papers without assigning any reasons thereof.
