**AUCTION SALE NOTICE**

Sealed Tenders are invited for auction sale of condemned mobile van bearing No. OR02L8030, of Odisha State Civil Supplies Corporation Ltd., Gajapati on "as is where is basis along with all available documents". The intending tenderers are requested to submit their tenders in plane paper offering their bids duly sealed along with one Bank Draft, worth Rs.5000.00(Rupees Five thousand) only as E.M.D drawn in any Nationalized Bank in favour of the District Manager, OSCSC Ltd., Gajapati. The tenderers are required to submit the tender papers strictly through Registered post / Speed Post / Courier Services. The last date of receipt of tender is dtd. 16.01.2023, at 05.00 PM. The tender papers received after the specified date and time as mentioned above, shall not be entertained and the same shall be out-rightly rejected. The sealed tenders shall be opened on the next day dtd.17.01.2023 at 11.00 A.M, in the office chamber of ADM (Rev.), Gajapati in presence of the tenderers or their authorized representatives, if they wish. The tenderers may inspect the vehicle kept in the premises of OSWC, Paralakhemundi during any working day from 10.30 A.M to 5 P.M.

The up-set price of Vehicle No. OR02L-8030 has been fixed at Rs.1, 15,000.00.

**Terms and Conditions:**

1. Tenders should be submitted by super-scribing "Auction sale of the vehicle No. OR02L8030" on the top of the closed envelope containing the E.M.D.
2. The tenderer with highest bidding shall be selected by the competent authority. He shall deposit 25% of the bid amount immediately on the spot and rest amount shall be deposited within 7(seven) days or at the time of taking delivery of the vehicle, whichever is earlier.
3. The EMD of all unsuccessful tenderers will be refunded to them within three days. & EMD of successful tenderer may be adjusted towards total bidding amount.
4. If the prices offered by sealed tenders are found less than the upset price, then competent authority may go for fresh auction sale or negotiation may be made with the highest bidder to fetch the minimum up-set price.

The highest offered value will be sent to Head Office for kind approval. After receipt of approval of MD vehicles will be disposed of by observing all other formalities.

5. In case the successful tender fails to deposit 75% of balance auction price at the time of taking of delivery of vehicle within 7 days, his/her deliver order will be cancelled and the EMD along with 25% deposit will be forfeited.
6. The highest bidder will remove the vehicle within 15 days of deposit of the total amount, failing which ground rent of Rs.100/- per day will be charged till final removal of vehicle.
7. After change of ownership by the highest bidder in his/her favour, or cancellation of registration of the vehicle at RTO Gajapati, the vehicle will be handed over to the highest bidder subject to production of documents in this respect. An agreement will be made with the highest bidder in stamp paper disposal of said vehicle and hence forth this office will not be responsible for any type of pending dues/penalties & claim etc as the case may be.
8. Where the ground rent so charged exceed the price deposited by the tenderer, shall ceased to have any right on the vehicle and amount so deposited by him will be adjusted towards ground rent. The vehicle shall become absolute property of the Corporation free from all encumbrances and it will be disposed of by fresh auction/tender as the case may be.
9. The authority reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
