GENERAL TERMS AND CONDITIONS

1. Specifications:

Malathion 50% EC shall be of the best quality and shall conform to ISI Specification no. IS:2567-1978 with up to date amendments and of recent manufacture, not more than one month old at the time of supply and should be acceptable in all respect to the Inspecting Officer/ OSCSC.

2. Packing:

Packing shall be as per IS:8190, part-II-1988 with up to date amendments. The material shall be packed in five (5) litres tins strong enough to withstand rough handling in transit. Two such tins shall be packed in one case.

3. Marking:

The container shall bear legibly and indelibly the information as required under IS: 2567-1978 and the Insecticides Act and Rules.

- a. Name of the Material.
- b. Name of the Manufacturer.
- c. Date/ Month of Manufacturer & Date/ Month of Expiry.
- d. Batch No.

4. Guarantee:

The expiry date of product shall be a minimum period of 02 years from the date of manufacture and guaranteed against any deterioration in quality within this period.

5. Documents to be submitted:

- i. Copy of CIB registration certificate
- ii. Copy of GST registration certificate
- iii. Copy of PAN card
- iv. Copy of Insecticide license
- v. Copy of BIS certificate
- vi. Copy of Manufacturing/ Trading license

6. Delivery:

The supplier shall deliver the materials at OSCSC storage godown situated at Mancheswar, Bhubaneswar in accordance with the terms and conditions of the purchase order and the supplier shall be responsible for any short-fall in unit.

7. Post Purchase Inspection :

Representative samples shall be drawn by the representative of OSCSC at the consignee end after delivery of chemicals by the supplier. The sample so drawn shall be submitted in a BIS accredited laboratory for test of quality as per specification. If the sample does not confirm to the prescribed specification, the whole consignment shall be returned to the supplier at his own cost. The payment shall be released subject to pass in the laboratory test. Inspection fees and testing charges of laboratory test shall be borne by the supplier.

8. Consignee's right of rejection:

Consignee i.e. OSCSC reserves the right of rejection of quotations without assigning any reasons thereof.
