

To terminate the contact at any time in case of non-satisfactory performance or violation of the contract by giving (two) months' notice in writing to the contractor at their last known place of residence /business and the contractor shall not be entitled to any compensation by reason of such premature termination. In such an event the transport contractor shall render complete account of CMR/any other foodgrains and any other information / documents in his custody and also arrange to complete that particular assignment as per the direction of the District Manager.</p>
