INVITATION FOR BIDS & NOTICE INVITING TENDER (NIT)**

1.1. The Seller: Odisha State Civil Supplies Corporation Limited (hereinafter referred to as "OSCSCL" or the "Seller"), a State Government of Odisha Undertaking, invites competitive online bids from eligible buyers for the sale of Rice on an "As Is Where Is, Whatever There Is, and No Complaint" basis.

1.2. Service Provider: The e-Auction shall be conducted online through NCDEX e Markets Limited (hereinafter referred to as "NeML" or the "Service Provider") via its portal <https://market.neml.in>, using the online trading system made available by NeML.

1.3. Governing Terms: Participation in the e-Auction implies complete and unconditional acceptance of all salient and detailed terms and conditions, schedules, and annexures prescribed hereunder.

2. SALIENT FEATURES OF E-AUCTION

- **Tender Fee:** Rs 5,900/- (Rs 5,000 + 18% GST) (*non-refundable*)

2.5 Security Deposit (SD)

Successful bidders must transfer a Security Deposit of 5% of the total trade value directly to OSCSCL's bank account within three (3) bank working days of receiving the Letter of Award (LoA). OSCSCL will release the Earnest Money Deposit (EMD) once the Security Deposit is received. The Security Deposit itself will be refunded after final settlement and the satisfactory submission of required export documents as mentioned in Annexure-II.

2.6 Payment of Contract Value

The successful buyer must deposit 99.95% of the total payment (comprising 99.90% toward the trade value and the remainder toward Platform Charges plus applicable GST) directly into the OSCSCL bank account on a mill- or godown-wise basis within seven (7) calendar days from the date of award, prior to the issuance of the Delivery Order. Partial payments are strictly prohibited. The remaining 0.10% held by NeML as Pre-Bid Deposit will be adjusted against TDS during final settlement; TDS will be booked against OSCSCL, and NeML must submit the corresponding TDS certificate to OSCSCL.

2.7 Lifting Window & Timeline

Full lifting of total allocated stock to be completed within thirty (30) calendar days from award date. Lifting is permitted only after receipt of 100% full payment Mill/Godown wise prior to issuance of delivery order/NOC.

2.8 Floor Price

OSCSCL reserves the right to prescribe a Disclosed or Undisclosed Floor Price in consultation with NeML.

2.9 Auction System

English auction system. Bidders must quote for the entire quantity specified for a particular lot/location.

3. COMMODITY SPECIFICATIONS, QUALITY, AND QUANTITY

3.1. As Is Where Is Basis: The Custom Milled Rice (CMR) stock is offered by OSCSCL strictly on an "As Is Where Is" basis at the storage locations specified in Annexure-I.



3.2. Minimum Lot Bidding: Bids received for less than the total specified quantity for a particular location and item shall be rejected.

3.3. Pre-Bid Inspection: Representative samples and stocks can be thoroughly inspected by prospective bidders between 10:00 AM and 5:00 PM on all working days at the respective godowns/mills prior to bidding.

3.4. Waiver of Quality Claims: The bidder must satisfy themselves regarding the quality, grade, moisture, and condition of the stock before participating in the e-Auction. No post-auction claims, disputes, or rejections regarding quality shall be entertained against OSCSCL or NeML.

3.5. Quantity Variation: The bid quantity specified in Annexure-I is approximate and subject to a variance of +/- 5% at the time of final delivery.

4. PRICE DISCOVERY AND BID EVALUATION

4.1. Floor Price Declaration: OSCSCL may declare a disclosed or undisclosed floor price for the offered stock in consultation with NeML.

4.2. Quote Structure: Prices shall be quoted on a delivered weight and quality basis on 'as is where is' terms, exclusive of APMC cess, GST, loading expenses, and statutory levies.

4.3. Evaluation Criteria: Evaluation and finalization of bids shall be conducted on the basis of the highest valid price quoted (H1) by the eligible bidders.

5. BID VALIDITY

5.1. Validity Period: All bids submitted at the final close of the e-Auction session must remain firm, valid, and legally binding for Seven (7) working days.

5.2. System Binding: Bids remain active in the system unless knocked off by a higher bid or closed at the end of the auction schedule.

5.3. Approval & Validity of Bids: OSCSCL shall convey its decision/acceptance within Seven (7) working days following the auction date. Upon issuance of consent by OSCSCL, the accepted prices shall remain valid until completion of lifting.

6. ELIGIBILITY CRITERIA & PREREQUISITES FOR BIDDING

6.1. Eligible Entities: Any individual, proprietorship, partnership firm, company, or legally constituted export house registered with NeML and holding a valid Import Export Code (IEC) is eligible to participate. **The deadline for registration is October 6th at 5:00 PM.**

6.2. 6.3. Mandatory KYC Submission: Bidders need to submit verified copies of the following credentials to NeML prior to auction participation:

6.3.1. Self-attested copy of Goods and Services Tax Registration Certificate (GSTIN)

6.3.3. Passport size photograph(s) of Authorized Signatory

- 6.3.8. Buyer Registration Fees- Rs. 5900/- (5000/- + 18% GST) charged by NeML.
- 6.3.9. The buyer is required to pay a non-refundable tender fee of Rs 5,900/- (Rs 5,000 + 18% GST) payable to OSCSCL.

- 6.3.11. CA Certified with UDIN No, the Balance sheet and Turnover certificate for the last three (3) financial years
- 6.3.12. Self-attested copy of Export-related data and supporting documents for the last three (3) years
- 6.3.13. Self-attested copy of Income-Tax return submitted for the last three (3) years
- 6.3.14. The Buyer must submit the Declaration-cum-Undertaking (Annexure-II) executed on a Rs. 100/- Non-Judicial Stamp Paper, duly signed and notarized, explicitly undertaking that the purchased rice stock shall be utilized **exclusively for export outside India**.

7. PRE-BID DEPOSIT AND EARNEST MONEY DEPOSIT (EMD)

7.1. The bidder shall deposit an amount equivalent to 2.10% of the total bid value in the Virtual Account provided by NeML prior to placing any bid. The Pre-Bid Deposit shall comprise of 2.00% towards Earnest Money Deposit (EMD) and remaining towards TDS under Section 393(1) [Table: Sl. No. 8(v)] of the Income Tax Act, 2025.

7.2. Alternative Bank Remittance: In the event a Virtual Account is not assigned, Pre-Bid Deposit may be remitted via online RTGS or electronic fund transfer to the below bank account:

7.3. Bidding Capacity Limit: NeML shall permit bidding only up to the limit backed by the available pre-bid deposit in the bidder's account.

7.4. Blocking and Refund of Pre-Bid Deposit: The Pre-Bid Deposit of the highest bidder (H1) will be blocked upon the conclusion of the auction, converted into 2% EMD and released by OSCSCL within seven (7) bank working days after the buyer submits proof of the Security Deposit (SD) payment. Pre-Bid Deposit for unsuccessful bidders will be refunded by NeML on the next working day following an online request submitted through <https://market.neml.in>.

8. ONLINE BIDDING / E-AUCTION SESSION MECHANISM

8.1. Auction Session: The auction session will open on the date and time specified by OSCSCL and NeML.

8.2. Dynamic Extension: If a bid is received within 3 minutes prior to the scheduled closing time, the closing time shall automatically extend by 5 minutes. Unlimited 5-minute extensions are permitted until 6:00 PM IST.

8.3. Bidding Platform: Bids must be placed online on the NeML portal <https://market.neml.in>.

8.4. Tick Size Increment: Prices must be quoted in **INR per Quintal**. Bids are subject to a mandatory minimum incremental tick size of **Rs. 1/- per Quintal** and a maximum tick size of **Rs. 500/- per Quintal**. Bidders are permitted to improve their bids multiple times during the active e-auction session.



8.5. Bid Modification & Non-Cancellation: Upward revision of bids is permitted during the auction. No bid cancellation or downward revision shall be allowed once submitted.

8.6. Binding Nature of Bids: The final results declared by NeML under OSCSCL direction are binding. Retraction or cancellation post-auction shall result in immediate forfeiture of EMD and blacklisting.

8.7. Forfeiture: In the event of forfeiture, the applicable platform charges shall be adjusted against the 0.10% from pre-deposit, subsequent to the transfer of the 2% EMD to OSCSCL.

8.8. Credential Security: Bidders are fully responsible for all actions executed using their allocated User ID and Password.

8.9. Auction Schedule: The auction schedule and timings are detailed in the attached Annexure-V.

9. INTERNET CONNECTIVITY AND TECHNICAL DISCLAIMER

9.1. Technical Failures: NeML and OSCSCL shall not be responsible for any power failure, network / bandwidth issues, server issue, hosting server issues, internet connectivity issues, ISP or any other related issues for the slowness to access NCDEX e Markets Platform (<https://market.neml.in>). In case the e-auction is not concluded / completed as scheduled for any reason whatsoever including technical reasons, NeML may, in consultation OSCSCL may reschedule the e-auctions on the same or different date on the same or modified terms and conditions, details of which shall be published on NeML's website.

9.2. Rescheduling Right: If an e-Auction cannot be completed due to technical disruptions, NeML in consultation with OSCSCL reserves the right to reschedule the auction to another date and time.

10. DOCUMENTS CONSTITUTING THE CONTRACT

10.1. Contractual Framework: The RFP, the Invitation for Bids, Terms & Conditions, online bids submitted on NeML, Letter of Acceptance (LoA) issued by OSCSCL, along with any written amendments, collectively constitute a binding contract between Seller and Buyer.

11. EMD Transfer and TDS Deduction

11.1 At least twenty-four (24) hours prior to participating in the auction, the Buyer shall deposit an amount equivalent to 2.10% of the bid value as a Pre-Bid Deposit into their Virtual Account. Upon approval of the bids by OSCSCL, NeML shall, within two (2) bank working days, transfer an amount equivalent to 2.00% of the bid value from the Pre-Bid Deposit towards EMD for the successful bidder(s) to the designated bank account of OSCSCL along with the tender fees collected from every participant. The amount towards applicable TDS shall remain blocked with NeML for subsequent deduction. The TDS u/s 393(1) [Table: Sl. No. 8(v)] (current applicable rate: 0.10%) under Income Tax Act, 2025 shall be deducted in the name of the seller upon receipt of confirmation from OSCSCL regarding the relevant transaction/delivery. TDS is applicable to seller. The amount deducted by NeML as tax will be deposited as per the rules of Income tax within the prescribed time limits. The deduction of tax shall be subject to change in the laws applicable from time to time.

Transactions on which TDS is deducted by NeML, in such cases buyer will not apply TDS u/s 393(1) [Table: Sl. No. 8(i)] under Income Tax Act, 2025.



11.2. Avoidance of Double Deduction: Where TDS has been deducted by NeML under Clause 11.1, the Buyer shall not execute duplicate TDS deductions under Income Tax provisions on the same transaction.

11.3. Statutory Revisions: Tax rates and statutory compliance terms shall adjust automatically in accordance with legal amendments enforced from time to time.

12. PAYMENT TERMS, LIFTING, AND PENAL PROVISIONS

12.1. NeML Payment Terms: Upon raising of invoice by NeML, the earmarked NeML platform charges plus GST shall be paid by OSCSCL within (15) fifteen days without delay or demur.

Note: Since NeML is only responsible for conducting the e- auction and is not responsible or liable for the quality, quantity, loading, transportation or any other activity relating to the commodity. Post approval of the auction by the authority, the Transaction Charges plus GST levied by NeML shall remain final, non-adjustable and non-refundable under all circumstances, including but not limited to cancellation of the auction, reduction or increase in quantity, failure to lift material, termination, forfeiture, dispute between parties, delay, default, force majeure event etc.

12.2 Deposit of Trade Value & Payment Terms: 100% payment (after adjusting the 0.10% TDS amount already deducted by NeML from the Pre-bid deposit) is required Mill/Godown wise and no partial payment will be allowed. The Buyer must deposit the full trade value for the respective Mill/Godown directly into OSCSCL's bank account (Annexure-III) via RTGS/NEFT within seven (7) calendar days from the award date.

12.3. Delivery Order (DO) / NOC: OSCSCL shall issue a Delivery Order / NOC only upon full 100% payment credit confirmation Mill/Godown wise. No delivery order will be issued against partial or incomplete payments. OSCSCL's responsibility for quality and quantity ceases completely once stock leaves warehouse premises.

12.4. The auction is strictly on a bagless basis; the buyer must arrange and bear the full cost of all required packing materials. Furthermore, the packaging must clearly state that the contents are intended exclusively for export and are not for domestic sale.

12.5. Lifting Timeline: Lifting shall be permitted only after 100% full payment is cleared for the respective Mill/Godown. The entire total allocated stock must be lifted within thirty (30) calendar days from the award date.

12.6. Extended Lifting Window & Charges: Subject to OSCSCL written consent, stock may remain in the godown for an additional extended period of up to thirty (30) calendar days, subject to upfront payment of:

12.6.1. Godown Storage Rent: Rs. 5.39 per bag of 50 kg per month.

12.7. Default and Deposit Forfeiture: If required payments are not remitted or if stock is not lifted beyond the permitted extended period, OSCSCL reserves the absolute right to terminate the contract and forfeit the Security Deposit (SD) without prior notice. In Case if Successful bidder not able to pay SD amount within the stipulated time period, then the EMD will be forfeited.

12.8. Loading & Weighment Charges: All labor, loading, weighment, and transport expenses at the godown or mill shall be borne exclusively by the buyer. For godown pickups, the buyer is specifically responsible for all expenses related to destacking, destitching, heaping, packing, stitching, and loading.

12.9. Seller Default Refund: If OSCSCL fails to deliver the stock due to unavoidable operational constraints despite full compliance by the buyer, OSCSCL shall refund the EMD, Security Deposit, and trade balance to the buyer without interest within seven (7) bank working days.

12.10. End-to-End Tracking: The Buyer shall maintain complete records of lifted stock and submit proof of utilization and export/end-use to OSCSCL as required. Following the satisfactory submission of the required



export documents as mentioned in Annexure-II and final settlement, the Security Deposit will be released to the Buyer within seven (7) bank working days.

12.11. Mandatory Undertaking: The Buyer must execute and submit the Declaration-cum-Undertaking in Annexure-II on Rs. 100/- non-judicial stamp paper prior to stock delivery.

13. PRE BID MEETING

A pre-bid meeting to address queries regarding terms and conditions will be held on **September 30th at 11.00 AM** under the chairmanship of the Managing Director, Odisha State Civil Supplies Corporation. The meeting will be accessible both in person and in virtual mode.

14. FORCE MAJEURE

Force Majeure Event” means any event or circumstances or combination of events or circumstances which:

- I. Are beyond the reasonable control of the Party affected by such event (the Affected Party); and cannot by exercise of reasonable diligence, reasonable precautions and reasonable alternative measures (where sufficient time to adopt such precautions or alternative measures before the occurrence of such event or circumstances is available), be prevented or caused to be prevented.
- II. Materially and adversely affects such Party's performance of its duties or obligations or enjoyment of its rights under this Service Order / Agreement.
- III. . As soon as practicable and in any case within 7 (seven) days from the date of occurrence of a Force Majeure Event or the date of knowledge thereof, the Affected Party shall notify the other Party of the same, setting out the details of the Force Majeure Event.
- IV. . If the Affected Party is rendered wholly or partially incapable of performing any of its obligations under this Service Order / Agreement because of a Force Majeure Event, it shall be excused from performance of such obligations to the extent it is unable to perform the same on account of such Force Majeure Event.
- V. If a Force Majeure Event described above, in the reasonable judgment of the Parties, is likely to continue beyond a period of 6 (six) months or any other period as stipulated in the Bid document, the parties may mutually decide to terminate the Service Order / Agreement or continue the Service Order / Agreement on mutually agreed revised terms.

15. TERMINATION

OSCSCSCL may terminate the contract for insolvency, breach, negligence, policy change, or statutory violation. Termination may include forfeiture of security deposit and recovery of losses. One-month notice may be issued for policy-related termination.

16. DISPUTE RESOLUTION, ARBITRATION, AND JURISDICTION

16.1 The Bidder and OSCSCSCL shall endeavor their best to amicably settle all disputes arising out of or in connection with the Contract in the following manner:



- a. The Party raising a dispute shall address to the other Party a notice requesting an amicable settlement of the dispute within seven (7) days of receipt of the notice.
- b. The matter will be referred for negotiation between OSCSC Ltd. and the Authorized Official of the Bidder. The matter shall then be resolved between them and the agreed course of action documented within a further period of 15 days.
- c. In case it is not resolved between OSCSC Ltd. and the bidder, it will be referred to the Principal Secretary, FS & CW Department for negotiation, and his decision will be final and binding on both the parties.
- d. In case it is not resolved between OSCSC Ltd. and the bidder, dispute shall be referred to arbitration in accordance with the Arbitration and Conciliation Act, 1996 (as amended). The arbitration proceedings shall be conducted by a sole arbitrator mutually agreed upon by both Parties. The venue and seat of arbitration shall be Bhubaneswar, Odissa, and the language shall be English.

16.2. All legal proceedings shall be subject to courts located in Bhubaneswar, Odisha.

17. SERVICE PROVIDER DISCLAIMER & INDEMNIFICATION

NeML shall not be liable for any dispute between the buyer and seller. NeML shall indemnify OSCSC for all losses claims or penalties arising from the gross negligence or willful misconduct of NeML only with respect to conduct of e auction on its platform and no other.

18. CORRUPT PRACTICES AND BLACKLISTING

18.1. Prohibition of Corrupt Acts: Offering bribes, commissions, or undue favors to any officer/employee of OSCSCL or NeML shall lead to immediate tender disqualification, criminal prosecution, and forfeiture of deposits.

18.2. Canvassing & Blacklisting: Canvassing in any form or attempting to influence auction processes shall be treated as a material breach, resulting in blacklisting of the Buyer for a minimum period of three (3) years.
